Also in attendance were Robert Caldwell (Fiscal Officer), Eric Snowden (Zoning Coordinator/Inspector), Doug Stewart (Fire Chief/Director of Departments), Peter Griggs (Brosius, Johnson & Griggs), Michael Loughry (attorney) and members of the public.

Ms. Sloat presented the agenda which was reviewed, modified as necessary and approved.

Robert Caldwell, Fiscal Officer, provided the Board with updated financial reports (receipt account status, appropriation status and fund status). Mr. Caldwell presented the pending warrants as detailed in the "Pending Warrant Report," for payment. The Fiscal Officer certified that there were sufficient funds to pay the bills. ## Department Reports

Public Safety Officer

The Deputy reported that they are working traffic accidents and package thefts in the area.

### Director of Departments

Mr. Stewart reported that the current rate the Township is paying for seasonal workers is not competitive with the market. He noted the issues the Ohio Department of Transportation is encountering in hiring snowplow drivers. Following discussion it was moved by Megan Sloat and seconded by Barry Adler that the Jerome Township Board of Trustees adopt the following resolution:

The Jerome Township Board of Trustees approve the pay rate of \$18 per hour for seasonal/parttime employees who snowplow and mow and \$16 per hour is they only perform either one but not both of the duties.

As part of the discussion, Mr. Stewart stated that he felt the current staff is underpaid compared to the Mid-Ohio Regional Planning Committee survey.

- Preparations taking place in anticipation of the winter storm

#### Old Business

Mr. Stewart provided the Board with an updated schedule of cemetery fees as well as updated procedures and rules. He indicated that the documents are being reviewed by the Prosecuting Attorney and asked the Board to delay any action until that review is completed. He noted that the Prosecutor's office as well as the insurance company are reviewing the rental agreement.

Ms. Davis wished to address the public regarding questions she has received regarding the Township's actions to Dublin City School District's redistricting plans. She stated that the Board cares about things that affect our children, however the Township has no legal jurisdiction regarding redistricting matters. Redistricting rests with the superintendants of the schools. In addition, she stated the Township does not have the authority to ask for impact fees for zoning legally through the Ohio Revised Code,

Mr. Adler reported that as the liaison with Fairbanks Local School district he attended a recent meeting where he was impressed with how the school was working with its residents.

Mr. Adler indicated the Dublin Chamber of Commerce's request for Jerome Township to become a member. The Board asked for more information before moving forward.

Mr. Adler asked the Board to consider undertaking some strategic planning to assist the Board with focusing and prioritizing, including such things as economic development planning. Ms. Sloat indicated that strategic planning cam be very involved and the Board would need to consider the scope along with the workload of addressing the comprehensive plan with other items. Mr. Adler clarified that he was thinking more of addressing the prioritization of items than a detailed strategic plan. The Board agreed to address this further. It was moved by Megan Sloat and seconded by Barry Adler that the Jerome Township Board of Trustees adopt the following motion:
