The Jerome Township Board of Trustees approve the Resolution to Proceed with on Levy a Tax in Excess of the Ten Mill Limitation for an additional levy of 5.5 mills for fire, ambulance and emergency medical and related services under Section 5705.19(I) of the Ohio Revised Code.
