The Jerome Township Board of Trustees met in regular session on October 15, 2019 at 8:05 p.m. following two public hearings. Board Vice-Chairman C.J. Lovejoy called the meeting to order and led the Pledge of Allegiance. Ronald Rhodes and C.J. Lovejoy answered the roll call. Joe Craft was absent. Also in attendance were Robert Caldwell (Fiscal Officer), Eric Snowden (Zoning Coordinator/Inspector), Doug Stewart (Fire Chief/Director of Departments) and members of the public.

Mr. Lovejoy presented the agenda which was reviewed, modified as necessary and approved.

Mr. Caldwell asked the Board to approve the following amendment to the 2019 Appropriations Resolution which he indicated is primarily necessitated by the fact that the final payroll of 2019 will be issued on Tuesday, December 31 rather than the holiday of Wednesday, January 1. Thus making this a twenty-seven pay date year. It was moved by Ron Rhodes and seconded by C.J. Lovejoy that the Jerome Township Board of Trustees adopt the following resolution:

- Transfer \$9,000 from Appropriation 01-A-25 "Contingency" to Appropriation 01-A-81 "Salaries - Administration" General Fund
- Transfer \$1,018 from Appropriation 04-A-04 "Tools and Equipment" to Appropriation 04-A-01 "Salaries Trustees" Road and Bridge Fund.
