Meeting

The Jerome Township Board of Trustees met in regular session on July 16, 2018 at 7:00 p.m. Board Chairman Ronald Rhodes called the meeting to order and led the Pledge of Allegiance. Ronald Rhodes and C.J. Lovejoy answered the roll call, Joe Craft was absent. Also in attendance were Robert Caldwell (Fiscal Officer), Doug Stewart (Fire Chief), Andrea Weaver (Union County Auditor) and members of the public.

Mr. Rhodes presented the agenda which was reviewed, modified as necessary and approved.

Andrea Weaver, Union County Auditor, addressed the Board indicating that her office has been very busy. She reported that 2019 would be a revaluation year with the collection year of 2020. She asked if the Township Hall would be available to conduct information meetings as they had done in the past in the August time frame. She also reported that there will be soil rate changes for CAUV which will most likely result in a decrease in taxes for these properties. She provided the Board with current millage rates and estimated values.

Mr. Caldwell presented minutes for approval. It was moved by Ron Rhodes and seconded by C.J. Lovejoy that the Jerome Township Board of Trustees adopt the following motion:

Department Reports

Public Safety Officer

Deputy C. Myers introduced himself as the new meeting liaison and provided a brief background along with an update of a recent assault call and traffic accidents.

Roads/Parks

The Board indicated that there was an issue again with a road in the Woodbine development. In addition, they indicated receiving reports that Ketch Road was being torn up by trucks as a result of a resident digging a pond. The Union County Engineer is to look at the matter and provide guidance.

Fire Division

Doug Stewart, Fire Chief, indicated that the 2017 Fire Code needs to be adopted and there are specific actions that will need to take place which he will be working on.

He reported to the Board that the Department has been encountering a number of issues with the current radios. He stated that service issues have occurred due to the age of the radios. He stated he reached out to three vendors to receive quotes including Motorola, E.F. Johnson and Kenwood. Of the three he stated that the best value was E.F. Johnson through a state term contract in the amount of \$93,550. He noted that this was approximately half the cost of Motorola radios. It was moved by Ron Rhodes and seconded by C.J. Lovejoy that the Jerome Township Board of Trustees adopt the following resolution:

The Jerome Township Board of Trustees approve the purchase of new radios for the Fire Division from E.F. Johnson via state term schedule at a cost of \$93,550.

Chief Stewart reported that he had received the preliminary ISO report in which the department would drop from a rating of 4 to a six. He stated that this primarily related to staffing. He added that he has sixty days to provide a plan to maintain the current rating and the department would have one year to achieve the plan.

He informed the Board that Dublin City Schools would have a levy on the November ballot for the construction of two schools in Jerome Village, with anticipated construction dates of 2020 and 2021.

Old Business

The Board indicated they wished to continue the discussion of limited home rule at a time when the full Board was present.

At 7:42 p.m. it was moved by C.J. Lovejoy and seconded by Ron Rhodes that the Jerome Township Board of Trustees adjourn. The motion carried.
