The Jerome Township Board of Trustees met in regular session on October 1, 2018 at 8:35 p.m. following two public hearings. Board Chairman Ronald Rhodes called the meeting to order and led the Pledge of Allegiance. Ronald Rhodes and Joe Craft answered the roll call, C.J. Lovejoy was absent. Also in attendance were Robert Caldwell (Fiscal Officer), Mark Spagnuolo (Zoning Inspector), Doug Stewart (Fire Chief) and members of the public.

Mr. Rhodes presented the agenda which was reviewed, modified as necessary and approved.

Mr. Caldwell presented minutes for approval. It was moved by Joe Craft and seconded by Ron Rhodes that the Jerome Township Board of Trustees adopt the following motion:

Department Reports

Public Safety Officer

Deputy C. Myers reported that there has been a rise in thefts from unsecured vehicles. He recommended that cars and garages be locked to deter criminals looking for an easy target.

Roads/Parks

Mr. Rhodes reported that repairs to the damage on Ketch Road should be taking place and he will take a look. Mr. Craft reporting the work was progressing on the storm drain matter in Arnold.

Planning/Zoning

Mr. Spagnuolo reported that the zoning map had been updated for recent changes and was available on the website and had been sent to the LUC.

Mr. Craft asked about the status of the Zoning Commission work sessions. Mr. Spagnuolo stated that sections 300 and 645 where expected to be given to the Board for review at the October 22 meeting. Mr. Craft asked if the changes had been reviewed by legal counsel. Mr. Spagnuolo responded that they have been reviewed by the Union County Prosecutor's Office.

Mr. Rhodes indicated the need to review the possibility of hiring an administrative assistant to help with various zoning functions. Mr. Spagnuolo provided a summary of possible duties. Mr. Craft asked about the results of having a summer intern, such as a list of items that were to be accomplished and those that were. Mr. Spagnuolo indicated that a number of files had been organized allowing for items to be located in a more efficient manner. Mr. Craft stated that he favored the college intern approach indicating that having tasks that are more project oriented would be most efficient.

Fire Division

Doug Stewart, Fire Chief, provided the following report:
