The Jerome Township Board of Trustees met in regular session on October 15, 2018 at 7:00 p.m. Board Vice Chairman Joe Craft called the meeting to order and led the Pledge of Allegiance. Joe Craft and C.J. Lovejoy answered the roll call, Ronald Rhodes was absent. Also in attendance were Robert Caldwell (Fiscal Officer), Doug Stewart (Fire Chief) and members of the public.

Mr. Craft presented the agenda which was reviewed, modified as necessary and approved.

Mr. Caldwell asked the Board to approve the following amendment to the 2018 Appropriations Resolution. It was moved by Joe Craft and seconded by C.J. Lovejoy that the Jerome Township Board of Trustees adopt the following resolution:

The Jerome Township Board of Trustees amend the 2018 Appropriations Resolution as follows:

Jim Cogar of the Union County Health Department wished to address the Board regarding the upcoming levy. He indicated the levy is a renewal of an expiring levy with a .15 mill increase. He explained that the renewal with an increase provided tax savings to property owners verses a replacement levy. In addition, Mr. Cogar provided an update on the septic system assessments. He reported that of the 1,003 known systems, 750 assessments have been completed with the remained to be completed in 2019. He concluded by reporting that inspection of these systems would take place in 2020.
