The Jerome Township Board of Trustees met in regular session on December 3, 2018 at 7:00 p.m. Board Chairman Ronald Rhodes called the meeting to order and led the Pledge of Allegiance. Ronald Rhodes, Joe Craft and C.J. Lovejoy answered the roll call. Also in attendance were Robert Caldwell (Fiscal Officer), Doug Stewart (Fire Chief) and members of the public.

Mr. Rhodes presented the agenda which was reviewed, modified as necessary and approved.

Mr. Caldwell presented minutes for approval. It was moved by Ron Rhodes and seconded by C.J. Lovejoy that the Jerome Township Board of Trustees adopt the following motion:

The Jerome Township Board of Trustees waive the reading and approve the minutes of the special meeting of November 16, 2018.

Public Participation

Kyle Russell, a local Boy Scout, addressed the Board regarding his Eagle Scout project. Mr. Russell reviewed his project plan for the New California Cemetery to include the following:

- Renovate existing headstones for Veterans including cleaning, straightening, reinforcing and requesting replacement markers through the National Veterans Administration Cemeteries
- Establish a public directory so people know where the Veterans' graves are located on the site
- · Purchase and install a flagpole with solar lighting
- · Raise funds to complete the project

Roads/Parks

Mr. Rhodes reviewed a list of outstanding road matters supplied by the Road Division that needed to be addressed.
