Board Chairman Megan Sloat called the meeting to order and led the Pledge of Allegiance. Megan Sloat, Barry Adler and Wezlynn Davis answered the roll call. Also in attendance were Robert Caldwell (Fiscal Officer), and members of the public.

Ms. Sloat presented the agenda which was reviewed, modified as necessary and approved.

Mr. Caldwell presented minutes for approval. It was moved by Megan Sloat and seconded by Wezlynn Davis that the Jerome Township Board of Trustees adopt the following motion:

Fire Division

Mr. Caldwell also indicated that recent new hires had inquired about the ability to purchase supplemental life insurance. He stated that currently the Township offers \$50,000 of basic life for all employees but does not offer supplemental. He stated that supplemental life insurance is available to the Township through MedMutual Life at no cost to the Township, however, would require him to make voluntary deductions from employees' pay for premiums. It was moved by Barry Adler and seconded by Wezlynn Davis that the Jerome Township Board of Trustees adopt the following resolution:

The Jerome Township Board of Trustees approve participation with MedMutual Life to provide supplemental life insurance for employees who wish to enroll.
